Ethics and Integrity

- Do not directly or indirectly offer or promise any personal advantage to obtain or retain business. Suppliers must not pay or accept unlawful commission or bribery.
- Treat confidential information with care to avoid disclosure of such information unless disclosure is authorized or legally required.
- Provide transparent disclosures to our questionnaire (Maintain transparent and up-to-date records in disclosures
- Provide products that are not adulterated or misbranded within the meaning of any laws, rules, regulations, ordinances or orders of any federal, state or local authority
- Maintain transparent and up-to-date records in accordance with all applicable laws and regulations.

TRI-K INDUSTRIES SUPPLIER CODE OF CONDUCT

 Ensures that any hospitality with TRI-K Industries is only for the purpose of maintaining good business relations and at a reasonable level. It is strictly with no intention for business or personal gain. Gift exchange between suppliers and TRI-K employees should be avoided. Official company-to-company gift exchange is acceptable, but it should be kept transparent.

Human Rights

Child Labor

Under no circumstances should, Suppliers employ workers under the minimum age for work as specified by the local, state, and national laws.

Forced Labor

Suppliers should not engage in the use of indentured slave, bonded or other forced involuntary labor. Work is conducted on the basis of freely agreed and documented terms of employment.

Fair and equal treatment

Suppliers must operate with dignity, respect, and integrity in regard to treatment of its employees. Suppliers will provide equality of opportunity and treatment to individuals without regard to race, color, religion, gender, age, national or social origin, political affiliation, physical or mental disability, marital status, sexual orientation, or any other status protected by law, unrelated to an individual's ability to perform work.

Compensation

Suppliers will pay wages that meet or exceed the legal minimum standards or appropriate prevailing local industry standards. It also includes equal remuneration for men and women for work of equal value.

Working Hours.

Suppliers will comply with applicable local, state, and national laws and industry standards on regular and overtime working hours.

Harassment and Violence

Suppliers will treat their employees with dignity and are committed to providing a work environment that is free of physical, verbal, sexual, psychological or any other form of harassment. It prohibits any type of violence or threat of violence and corporal punishment in the workplace.

Freedom of Association

Suppliers will recognize and respect employees' rights to freedom of association and collective bargaining. Suppliers will also facilitate open communication and direct engagement between workers and management.

Legal Compliance

At a minimum, Suppliers will comply with all applicable local, state, and national laws regarding human rights where the company does business.

Safety, Health and Environment

All suppliers of TRI-K Industries INC. are expected to

- Comply with all applicable safety, health and environmental laws and regulations.
- Ensure safety in handling and transportation of materials in accordance with national and international environmental laws and regulations.
