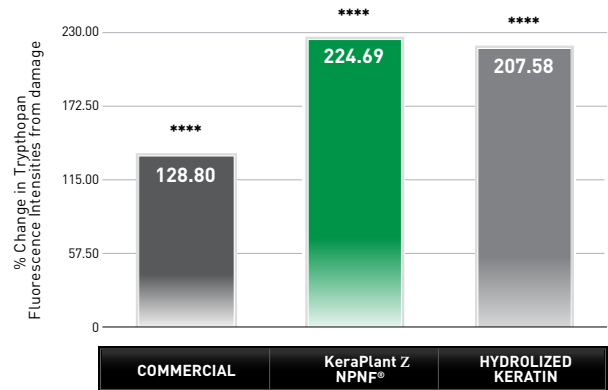

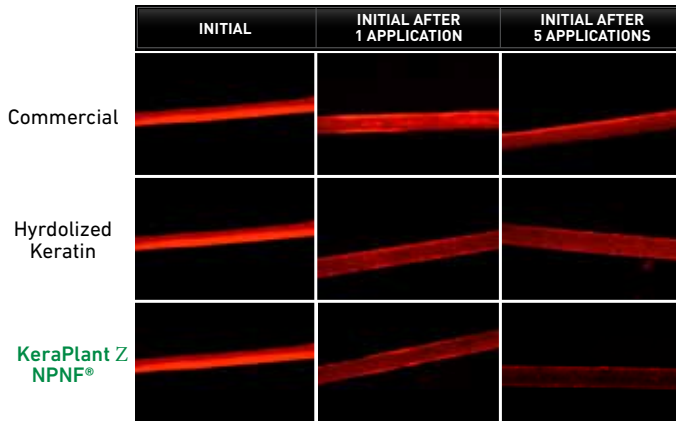

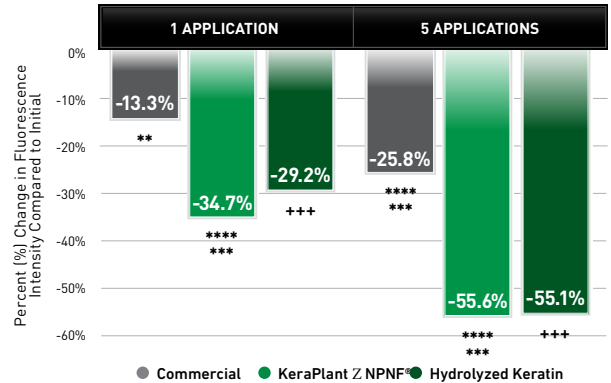

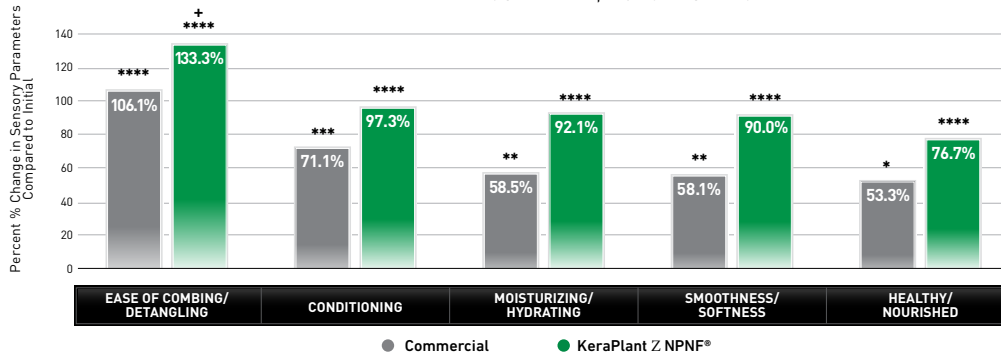
SINGLE BLEACHED CHINESE HAIR, 1% IN FORMULATION
